INSTRUCTIONS FOR LISTING – PLEASE READ CAREFULLY

This tax listing form MUST be completed and returned to the Brunswick County Tax Office, postmarked no later than January 31, 2015 or you will be charged a late listing penalty in the amount of 10% of the total taxes due on personal property.

NOTE: The Tax Office **WILL NOT** change your mailing address unless you indicate a change in the area marked “**Make Address Corrections Here**”.

Section 1 - Indicate the physical address of your property.

Section 2– If someone has a mobile home (Single-wide or Double-wide) on your property that does not belong to you, please provide their name and address. Mobile home park owners are required by General Statute 105-316 to provide a list of names of owners of mobile homes in parks.

Section 3 – Single-wide mobile home/ or camper owners must list every year as personal property. Indicate the brand name, year, width, length and physical address. If pre-printed information in mobile home section is correct, do not list your mobile home again on this form.

Section 4 – Farmers must list all tractors, combines, equipment, using additional paper if necessary. 1987 tax law changes exempt certain farm commodities from taxes. You must file a business form to receive the exemption. Please contact the Tax Assessor if you have questions about this exemption or if you think you may qualify.

Section 5 – Unlicensed Vehicles (cars, trucks, motor homes, Trailers of all types, Motorcycles, and Similar property), that do not have active license plates and registration decals must be listed. Permanent Multi-Year trailers licensed for multiple years with the NC Department of Motor Vehicles must be listed. Beginning in September 2013, you will pay the vehicle property tax when you renew your plate.

Section 6 – List Airplanes, Gliders and other personal property, providing the make, model, year, N-Number, original cost and Physical Address.

Section 8- PROPERTY TAX RELIEF FOR ELDERLY AND PERMANENTLY DISABLED PERSONS (BRUNSWICK COUNTY PERMANENT RESIDENTS ONLY):

North Carolina excludes from property taxes the greater of \$25,000 or 50% of the appraised value of a taxpayer’s primary residence who was at least 65 years of age on January 1, 2015 or is totally and permanently disabled and whose disposable **annual income does not exceed \$29,000**. The application deadline is June 1, 2015. For more information and an application contact the Brunswick County Tax Office, (910) 253-2829. North Carolina has created a circuit breaker benefit allowing qualifying elderly and disabled homeowners beginning with Tax Year 2010 to defer a portion of the property taxes assessed on their residences. Qualifying homeowners are those residents that are 65 years old or totally and permanently disabled; have occupied their residence for at least 5 years and earn no more than 150% of the income eligibility limit mentioned above. The application deadline is June 1, 2015. North Carolina has established a property tax exclusion for the first 45,000 in value for **Veterans** who have a 100% permanent and total service connected disability from the U.S. Department of Veterans Affairs on their primary residence. Application deadline is June 1, 2015.
