Summary: There are 79 ballots being considered at today's meeting.

Order of Ballot Consideration:

Ballots recommended for approval – board to spot-check¹ (page 3)

1. 20 Civilian ballots
 - a. 1 of these is a Bald Head Island ballot that will be opened separately to ensure both ballot sheets were received²
2. 4 Affidavit Review Pending Civilian ballots (properly executed Photo ID Exception Form³)

Ballots requiring board review⁴

1. Ballots recommended for approval (page 4)
 - a. 6 Civilian ballots with an Accepted Cure
 - i. 1 of these is a Bald Head Island ballot that will be opened separately to ensure both ballot sheets were received
 - ii. 1 of these was originally signed by a POA, which is not permitted.⁵
 - b. 2 Overseas ballots (received electronically, duplicated by bipartisan team during the meeting)

¹The Resolution to Delegate Administrative Duties Relating to Absentee Voting to the Director and Staff approved by the board on 10/17/23 states that "The board will not review individual ballot envelopes that have been recommended by staff for approval and will accept staff's recommendation for those ballot envelopes and photo ID documentation. The board will spot-check a minimum of two envelopes and accompanying photo ID documentation to ensure accuracy and consistency. The board reserves the right to review all ballot envelopes that have been recommended by staff for approval."

² Republican ballots for Bald Head Island voters consist of two sheets with unique barcode identifiers, indicating they belong together. In the first batch of mailed ballots, some sheets may have separated during the folding machine process.

³ Per Numbered Memo 2020-25, these ballots should be approved by the board if the board does not unanimously conclude that the exception form is false.

⁴ Numbered Memo 2020-25 states "the board must individually review all ballot envelopes that: (1) have been recommended for disapproval by staff, (2) have a cure certification associated with that ballot envelope, or (3) where staff need further guidance from the board as to whether the envelope was properly executed or the photo ID documentation meets all legal requirements.

⁵ Numbered Memo 2022-11 states that if a voter is physically unable to sign or make their mark due to disability, the person assisting with the ballot should write in the signature line, "Disabled - cannot sign" and must complete the Voter Assistant Certification located on the back of the ballot return envelope.

- a. 1 Civilian ballot where the voter indicated that their photo ID documentation is inside the ballot envelope⁶ (page 5)
- 3. Recommended for disapproval⁷: (page 6)
 - a. 2 Civilian ballots with incomplete witness information. These were received on election day. The voters were contacted.
 - b. 44 Civilian ballots returned after the deadline (Tuesday, 3/5/24 at 7:30 pm)

⁶ Numbered Memo 2021-03 states “A voter may respond to a notification that their ballot is missing photo ID documentation by stating that it is in the ballot envelope. If this occurs, staff must defer the review of the photo ID documentation to the next absentee board meeting, when the county board can review the application and, if approved, open the ballot envelope and confirm photo ID compliance.”

⁷ Numbered Memo 2020-25 states “Whether the county board delegates the initial review of absentee envelopes to staff or chooses to have a bipartisan team of board members review envelopes during the meeting, all board members present at the meeting must approve or disapprove the ballots.”

The Resolution to Delegate Administrative Duties delegated the task of “Inspecting ballot envelopes and return envelopes for deficiencies and contacting voters as required by Numbered Memo 2021-03.”

Agenda Item: Board Consideration of Provisional Ballot(s) Inserted into the Tabulator on Election Day

Summary:

It is believed that two provisional ballots were inserted into the tabulator at SB04 Southport 1 on Election Day.

Our office was notified at 4 pm that a curbside provisional ballot was placed in the tabulator. While reviewing the procedure with the help desk, they indicated that their audit count was one off (higher tabulator count than ATV count) and they suspect that another curbside provisional was placed in the tabulator.

Procedure:

Confirm seal numbers on the ballot bin.

The bipartisan team will look through the ballots. After the provisional ballot(s) are located, the ballot container will be resealed with security seals.

The provisional ballot(s) will be tallied by the bipartisan team.

The white tally sheet will be attached to the provisional ballot and placed in a basket for manual entry.

The colored tally sheet will set aside for administrative use.

ON FRIDAY DURING CANVASS

- Using the tally sheets, a manual edit will be added to the proper precinct results in the proper reporting group to deduct any ineligible votes.
- Two copies of the audit log page showing a manual edit will be printed. One report is attached to the tally sheet and one report is attached to the official canvass report.

IF PROVISIONAL APPLICATIONS APPROVED

- If the board approved the provisional voting applications, then the provisional ballots will need to be duplicated by the bipartisan team.
- The tally sheet and the original provisional ballots (after duplication) will be placed in an envelope and sealed in a ballot bin.
