Agenda Item: Polling Place Change

Summary:

At the July 16, 2024, Regular Meeting, the Board approved changing the polling place for CB04 Secession 2 from the Holden Beach EOC to Sabbath Home Baptist Church. Since this is an out-of-precinct polling location, the change was also approved by the Executive Director of the State Board of Elections.

However, before entering into a written agreement, Sabbath Home Baptist Church rescinded their consent for use as a polling place.

To revert to the previous polling place, which is also out of precinct, the Board must pass a new resolution. Unanimous approval is required for this action.

**RESOLUTION OF THE BRUNSWICK COUNTY BOARD OF ELECTIONS
TO MOVE PRECINCT CB04 SECESSION 2 TO A
POLLING PLACE OUTSIDE PRECINCT BOUNDARIES**

WHEREAS, G. S. § 163-128 authorizes the Brunswick County Board of Elections the authority from time to time, by resolution, to establish, alter, discontinue, or create such new election precincts or voting places as it may deem expedient; and

WHEREAS, G. S. § 163-130.1 authorizes the Brunswick County Board of Elections to establish a voting place that is located outside that precinct by unanimous vote of all its members; and

WHEREAS, the current polling place, located out of precinct, Sabbath Home Baptist Church, is a private facility and has rescinded their consent for use as a polling place; and

WHEREAS, the facility formerly used for Precinct CB04 Secession 2, Holden Beach EOC Building, which was also out of precinct, is amenable to use as a polling and there is no other facility that is adequate to serve as polling places within the precinct boundaries; and

WHEREAS, Holden Beach EOC has been used successfully for previous elections; and

WHEREAS, adjustments can be made with respect to precinct set-up, equipment, personnel, and parking to assist in alleviating previous concerns at Holden Beach EOC;

NOW, THEREFORE, BE IT RESOLVED, the Brunswick County Board of Elections, by unanimous vote, has decided to move the polling place for Precinct CB04 Secession 2 from Sabbath Home Baptist Church to the Holden Beach EOC Building, 1044 Sabbath Home Rd SW, Supply, NC 28462.
